This is in reference to your interview with us. On behalf of Cilicant Chem Private Limited, we are pleased to appoint you as a **Trainee** with the Company, inter-alia on the terms and conditions stated herein below, should you accept the appointment. This appointment is contingent on you timely providing the Company with appropriate documents establishing your identity and right to work in India.

**APPOINTMENT**

Job Position / Designation: Trainee

Area: Pune Office Unit 1

Role: Management Trainee

Your appointment will be effective from **1<sup>st</sup> Jun 2018**. You are required to join the Company on the said date. In the event, you do not join on the above-mentioned date, this appointment stands nullified unless the joining date is extended in writing by the Company.

You shall report to **Assistant Manager Dispatch**

**PLACE OF WORK**

Your place of work will be at the Company offices in **Pune, Unit 1**. The Company may require you to work out of such other location as the Company may determine in India and shall undertake such travel within India and overseas as the Company shall reasonably require in the proper performance of your duties.

There will be situations where it is in the Company's best interest to transfer you within a department or from one department to another. These transfers will occur when and where the Company feels it is appropriate. It is further understood and agreed that the Company may depute or second you to work at any of the Company's subsidiaries or affiliates or clients, in India or any other location, at the Company's option. The deputation, in each case, shall be approved by the Human Resource Manager of the Company. In the event, you do not consent to such transfer, your services with the Company may be terminated.

**TRAINING PERIOD**

For a period of one **1 year from the date of your joining** you will be appointed as a Trainee and will undergo training in different technology functions / departments as required by the Company.

Upon successful completion of the Training Period, the Company may at its sole discretion offer you employment with the Company on such terms and conditions as may be indicated to you at such time. Please note that nothing contained in this Appointment Letter obligates the Company to offer you employment at any time. Any offer of employment shall be valid only if it is in writing.

**COMPENSATION**

During the Training Period, you shall be paid a fixed gross monthly stipend of **INR 15500 Rupees** on monthly basis. During your Training Period, you will not be eligible for any other benefits applicable to the regular employees of the Company. Your compensation will be subject to applicable tax deductions and Central and State level levies as may be mandated under the Indian law at the time of such payment. Future adjustments in compensation, if any, will be made by Company in its sole and absolute discretion based on performance review. There is no contractual entitlement to any increase to compensation on such review.

Your stipend will be paid to you on monthly basis on or before **10<sup>th</sup> day of the month** immediately following the month for which it is due.
