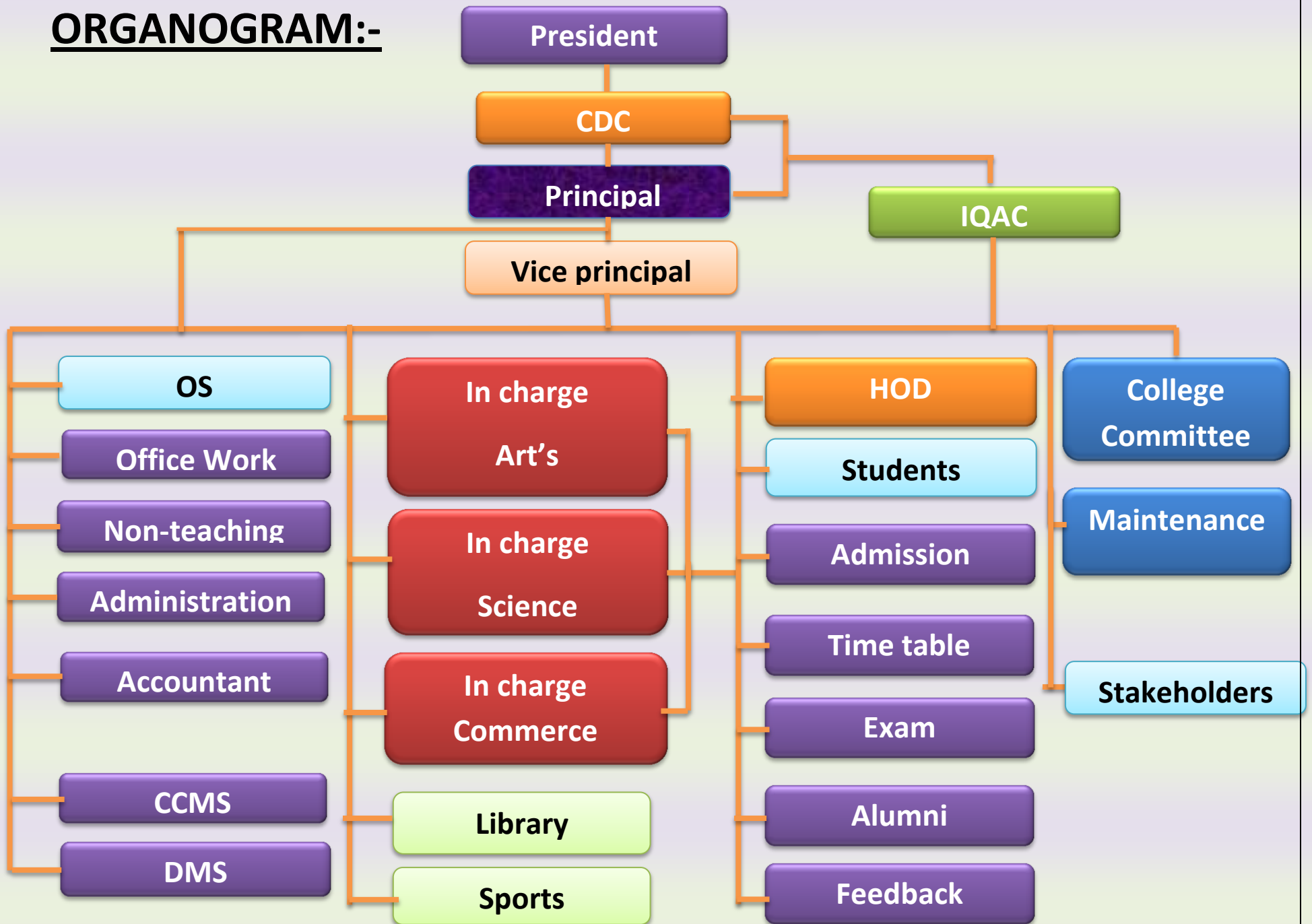

In exercise of the powers conferred by section 77-A of each of the University Act of 1974, that is to say, The Bombay University Act, 1974 (Mah. XXII of 1974), the Poona University Act, 1974 (Mah. XXIII of 1974), the Shivaji University Act, 1974 (Mah. XXIV of 1974), the Marathwada University Act, 1974, (Mah. XXV of 1974), the Nagpur University Act, 1974 (Mah. XXVI of 1974), the Shreemati Nathibai Damodar Thackersey Women's University Act, 1974 (Mah. XXVII of 1974), and section 86 of the Amravati University Act, 1983 (Mah. XXXVII of 1983), the Government of Maharashtra hereby makes the rules prescribing the Standard Code providing for the terms and conditions of service of the non-teaching employees of the Non-Agricultural Universities in the Maharashtra State (including its officers) and of those of the affiliated colleges and recognised institutions other than those managed and maintained by the State Government and Local authorities, namely :--

CHAPTER I
GENERAL

1. Short title, application and commencement — (1) These rules may be called the Maharashtra Non-Agricultural Universities and affiliated Colleges Standard Code (Terms and Conditions of Service of non-teaching employees) Rules 1984.

(2) These rules shall apply to all full-time non-teaching employees of the non-Agricultural Universities, and the affiliated colleges, other than those managed and maintained by the State Government and Local authorities, appointed on time-scale of pay.
