

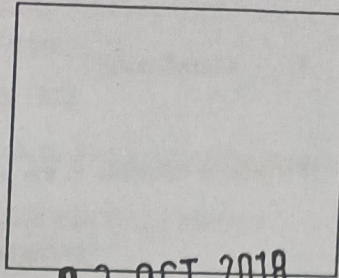

- c) To any persons sending a Life Certificate signed by some persons exercising the powers of Magistrate under the criminal Procedure Code, or by any Registrar or Sub-Registrar appointed under the Indian Registration Act, 1908 or by any Gazetted Officer or by a Munsiff or by a police officer not below the rank of Sub-Inspector incharge of a police station or by a Postmaster, a Departmental Sub-postmaster or an Inspector of police offices or by officers of the Reserve Bank of India and Public Sector Bank or by the Head of an Executive Committee of a Village Panchayat, Gaon Panchayat or Gram Panchayat or by the Head of an Executive Committee of a Village or by a Bank included in the second schedule to the Reserve Bank of India Act, 1934, in respect of persons drawing pension through that Bank.

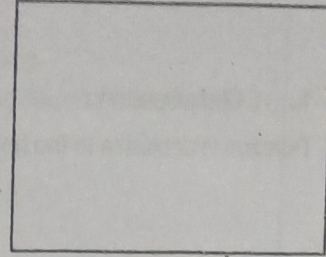

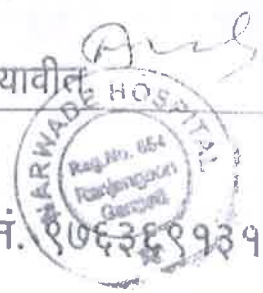
