- To ensure maximum participation of enrolled divyang students in all activities.
- To provide accessible and inclusive education at the institute to give them equal opportunities for development.
- To sensitize the teachers, students and non-teaching staff by conducting awareness program so that they can address the administrative and educational difficulties and evaluation procedures of the divyangs.
- To make reasonable changes in the educational plan and assessment framework to meet the particular needs of students with disabilities.
- To make the provision for easy access of all infrastructural facilities to the divyangs.
- To allocate the necessary budget to achieve above objectives.
- To ensure implementation of all legislations with respect to persons with disabilities.

### Outcomes:

- Separate quota is assigned for Divyangjans during admission.
- Divyangjans are offered special seating arrangement in classroom during the lectures and during examination in the examination hall.
- Scribe/Writer are provided during the Examination for required students
- Special reserved seating arrangement are made for divyangs during any college function,
- Suitable arrangements are made in washrooms and all other areas in the campus wherever necessary.
