- Mobilized and selected candidates should not be less than 18 years of age as on start date of training.
- The candidates should be selected only subject to their eligibility regarding Adhar and caste certificate & benefit of state of Maharashtra. He / She is not eligible even if he is resident of Maharashtra prior to notification of SC list (i.e.) 1950 (For MSSDS).

The primary selection of candidates for the skill development training will be done by Vipra Skill India, however BHARATIYA JAIN SANGHATANA'S ART'S, SCIENCE & COMMERCE COLLEGE will also supervise the selection process.

- Vipra Skill India is expected to provide candidates with all possible information on the nature of work in the sector/trade, availability of jobs, potential pay and entitlements, growth prospects and risks involved, with the aim of helping candidates and their families make informed choices.

2) Course Commencement

- Vipra Skill India shall start any course only after written confirmation has been received from Skill Development Office.

b. Course Content

1. Vipra Skill India shall ensure that the course material, syllabus, training schedule etc. are given to all the candidates immediately after the commencement of the course and should be as per latest industry standards.
2. Vipra Skill India shall ensure that all trainers deputed by them have the relevant education, experience and skill set for conducting the proposed trainings.

2) Assessment & Certification

- a. Vipra Skill India shall ensure periodical internal assessment on progress of each candidate throughout the course duration for taking remedial measures.
- b. Vipra Skill India shall provide certificates to the trained candidates on last day or any convenient day of closing as agreed. The certificate will be provided by skill development office.

4) Attendance

- b. No payment shall be made for the candidates who dropout, opt out, reject the offer letter, go for higher education or self-employment. It is the responsibility of Vipra Skill India to train only those candidates who are interested in employment.
- c. Vipra Skill India shall here to placement, location of placement, minimum salary, incentives, stipend etc. for all candidates.
- d. After completion of training, Candidates shall give placement,

6) Post Placement Tracking

Vipra Skill India shall maintain the record of all placed candidates who have been successfully placed for a period of 6 month from the date of joining and provide relevant information to VIPRA SKILL INDIA PVT LTD like salary slip (6 months), career plan, employer's feedback etc.

Bharatiya Jain Sanghatana's Arts, Science and Commerce College, Wagholi, Pune-412207 (BJSC) is a Jain Minority College accredited by NAAC with 'B' grade in the last two consecutive assessment cycles. The college is a premier academic institution with a vision "Exploring Youth Capabilities for Social Service" and with mission 'Persuasion of studies in

arts, science & commerce with vocational training based on the concept of earn-as-you learn principles and plethora of extracurricular activities to ensure all round growth'. - Guidelines for the activities follows will follow the policies and procedure which governs such arrangement at each level.





